In case of death the association pays \$1,000 to the estate of the deceased member, and when a member is disabled he receives \$500. The members of the branches meet at their rooms and discuss matters pertaining to sailing, invite admiralty lawyers to address them and have a school for their instruction on anything in the marine line.

The local branch will fit up a room at once and have maps a library, files of papers, etc.

The meeting in the Cowie building will continue all of to-day, beginning at 9:30 o'clock this morning. All masters are cordially invited to attend and see what they think of it. Capt. Clark expects to have seventy-five members in the Detroit branch by to-morrow.
