I would like to thank Bill Graham for continuing to maintain the lodge roster database in his computer. Keeping track of roster changes can be a daunting and time-consuming task and I appreciate Billy's assistance with the roster.

From all reports, the lodge picnic held on Sunday, July 22, 2001 on the grounds of the J.W. Westcott Company was a resounding success. Over 150 lodge members, auxiliary members and their guests turned out to watch the Parade of Tall Ships. Numerous other lodge members were observed in the Parade of Tall Ships itself, including Bill Hoey and Roger Stahl on Gaelic tugs, Bill Graham on the Yacht *Helene*, Luke Clyburn on the *Pride of Michigan*, Bob Kerr on the Tug *Forney* and several lodge members on the two Westcott mailboats. The temperature was in the low 90's, but large shade trees and breezes from the southwest helped to moderate the heat. The prevailing southwesterly breezes provided ideal conditions for the tall ships to exhibit their sails.

I want to mention a number of lodge and auxiliary members who were a great help to me in planning and setting up the lodge picnic. Tom McMullen and his brother-in-law Dave Williams did yeoman duty at the barbecue grills, an especially grueling job on such a hot day. Ron Ingram helped in handing out the cooked hot-dogs, brats and burgers, and his sons Mark and Alan helped in keeping picnic supplies replenished. Oscar Rosso provided an extra cooler and cooker for the picnic. Auxiliary members Mary Ann Ingram, Sue McMullen and my wife Sarah shopped for food and supplies, and set up and managed the food tables. The picnic-goers, by bringing dishes to pass, ensured that there was a fine array of food and plenty of it to go around. Finally, special thanks go to Jim Hogan, General Manager at J. W. Westcott Co., for hosting the picnic, and also to the staff at the mailboat for its work. I know that the mailboat crew, which includes several lodge members, went to great pains cutting grass and sprucing up the area so that everything was in readiness for the arrival of the lodge. All these extra efforts were very much appreciated.

In the "members in the news" department, the June 30, 2001 issue of the <u>Detroit News</u>, the July 19, 2001 issue of the <u>Detroit Free Press</u> and the August 2, 2001 issue of <u>Waterways</u> (a special section distributed with several suburban Detroit newspapers) all featured articles about the Westcott mailboat. Lodge members Sam Buchanan, Len Tanner, Mary Taylor and Jim Hogan were mentioned and/or pictured in those photo stories. Caution is urged when reading the <u>Waterways</u> article. While the gist of the article is generally correct, there are several errors of fact, including the spelling of vessel names, the location of mail slots and the date of the Fitzgerald sinking. Also, Sam Buchanan was misidentified as "Jim" Buchanan in a photo caption. Unfortunately, writers often get the details mixed up.

Also "in the news" was member Gus Balanda, our lodge's resident fitness guru. He was a participant in the Michigander cross-state bicycle ride, and was mentioned in a story about the cross-state bike ride that appeared in the July 26, 2001 issue of the Detroit Free Press.

During planning sessions for the Parade of Tall Ships, lodge President Ken Gerasimos had prepared a list of several lodge members willing to serve as volunteer pilots aboard tall ships that might require assistance in navigating the lower Detroit River. Most of the tall ships did not require assistance, but at the last minute one of the ships contacted the lodge in hopes of utilizing the services of a volunteer pilot. Member Mike Gerasimos volunteered to assist. He helped pilot a tall ship called the *Amara Zee* from Toledo, Ohio to Bay City, Michigan. The *Amara Zee*, currently on a tour of the Great Lakes, is a tall ship manned by thespians. The actors put on performances using the vessel itself as a stage. Capt. Gerasimos deserves the thanks of the lodge for offering his time and expertise to the *Amara Zee*.
