CWB Marquis was introduced by Ian White, President & CEO of the Canadian Wheat Board (CWB). The ship's sponsor was CWB Chief Strategy Officer Dayna Spiring, and the benediction was given by Rev. Ed Swayze of the Thunder Bay Mis-

sions to Seamen. Following the ceremony, the ship was open for tours by officers and crew. **Seann** reports that *CWB Marquis* has already carried more than 360,000 metric tonnes of grain from the Lakehead to the east coast for export since entering service this spring.

## Georgian College MED Centre Secures Funding

On June 23, 2015, Georgian College announced that funding has been secured for a new Marine Emergency Duties (MED) Training and Research Centre to be built at the Owen Sound campus. C\$3.92 million in joint funding was acquired from the governments of Canada and Ontario through the Small Communities Fund. Construction will begin immediately.

The facility will provide mandatory marine training in fire-fighting, survival craft, life raft and immersion suit training, as well as first aid. Without this Ontario facility, the closest English-language institution offering MED training is currently in Prince Edward Island.

#### **Marine Casualty Reporting NVIC**

On July 21, 2015, the US Coast Guard released Navigation and Vessel Inspection Circular No. 01-15, in which the Coast Guard clarifies marine casualty reporting requirements. In addition to advising operators of how the reporting rules should work, the document instructs Coast Guard officers to update their policies and procedures for consistency. #### **Updated Mariner Credentialing Forms**

The Office of Management and Budget approved the US CG-719 series of forms (B, K, K/E, P, S, and C) that will replace the forms displaying a June 30, 2012, expiration date. The new K and K/E forms reflect the introduction of the Medical Certificate. The C is a new non-mandatory form that standardizes disclosure of conviction information. Updated instructions will be provided with each form.

The US Coast Guard will not stock the CG-719 series of forms in paper format. Beginning October 1, 2015, forms may be obtained electronically in a fillable PDF format by selecting the forms link on the NMC website. Implementation of the new forms will commence on October 1. With the exception of the K and K/E, the Coast Guard will no longer accept outdated forms after April 1, 2016. For the K and K/E, forms signed by a physician after December 31, 2015, must be the new form version. ## **Merchant Mariner Credential Production**

On July 30, 2015, the US Coast Guard's National Maritime Center announced improvements in the physical production of Merchant Mariner Credentials (MMCs). Automated printers will improve the quality and security of the credentials. #### **Engine Ratings on Two-Watch System**

The Howard Coble Coast Guard and Maritime Transportation Act of 2014 amended 46 USC 8104(g)(1) to permit engine ratings on certain vessels to be divided into at least two watches. The NMC has revised its sea service credit to 1½ days of service credit for each day a total of 12 hours is worked by QMEDs, wipers, and oilers serving on affected vessels. #### LCA State of the Lakes Report

On June 30, 2015, Lake Carriers' Association issued its "State of the Lakes" report in which progress was reported on issues vital to the future of the Great Lakes shipping industry. #### **Council of Great Lakes Governors**

The Council of Great Lakes Governors (CGLG) met in Quebec from June 12-14, 2015, for their Leadership Summit. "Connecting across Borders" was the theme of the meeting, with the intention to strengthen connections among the region's states and provinces, and to better connect the region with the world. To coordinate future work, CGLG launched a new Conference of Great Lakes and St. Lawrence Governors and Premiers.

**Rick Snyder**, Governor of Michigan and Chair of CGLG, said, "This Conference builds on our longstanding relationships as Governors and Premiers, and will bring us together as ten equal partners united in our commitment to sustainably grow the region's economy. We announced a series of ambitious actions to grow our region's economy and protect the world's greatest freshwater system."

In addition to creating the Conference of Great Lakes and St. Lawrence Governors and Premiers, actions taken at the Leadership Summit include:

- Pledging to develop a strategy to double maritime trade, shrink the environmental impact of the region's transportation network, and support the region's industrial core;
- Further protecting the region from aquatic invasive species by fully operationalizing a regional mutual aid agreement, and launching an innovative pilot grogram among Michigan, Ohio, and Ontario to harmonize aquatic invasive species regulations;
- Combating nutrient pollution and harmful algal blooms in Lake Erie through a landmark agreement;
- Creating a new program to foster regional economic clusters based on analysis by Harvard Business School;
- Announcing multi-sector missions to promote exports to China, Europe, South America, and Central Asia.

## **Chicago Area Waterway System Dredged Material Management Plan**

On July 15, 2015, Lake Carriers' Association commented to the US Army Corps of Engineers, Chicago District, on the Chicago Area Waterway System Dredged Material Management Plan, specifically referring to Calumet Harbor. LCA President Jim Weakley said, "It is critically important that Calumet Harbor be dredged to project dimensions on a regular basis. The vessels that serve that harbor lose anywhere from 50 to 125 tons for each inch of draft lost to inadequate dredging. Therefore, we fully support the Chicago Area Waterway System Dredged Material Management Plan, as it will provide the capacity to dredge the Chicago Area Waterway System for the next 25 years. The economy and the environment will benefit from maintaining Calumet Harbor..." #### S. 1680

US Senate Bill S. 1680, the National Multimodal Freight Policy and Investment Act, was introduced in the US Senate (sponsored and co-sponsored by east and west coast Senators) on June 25, 2015, and referred to the Committee on Commerce, Science, and Transportation. The legislation is described as "A bill to improve the condition and performance of the national multimodal freight network, and for other purposes."
