

## **Members Working Line 5 in Straits of Mackinac**

Many ISMA members from various local lodges are involved with the work being performed in the Straits of Mackinac on the Enbridge Line 5 project.

PGP and Northeast Michigan Lodge #19 member Lee Barnhill pushed a jack up barge with Tug Nancy Anne to six shallow water sites on the north and south shores for a drilling crew to do geotechnical borings for the proposed tunnel project that is to replace the existing twin pipelines.



Lodge #19 member **Will St. Amour** and PGP **Lee Barnhill** ran a crew boat on alternating 12-hour shifts to the jack up barge for approximately seven weeks while the drilling crew and scientists performed their work.



In late June, the drill ship *Highland Eagle* from London, England, made it into the Great Lakes and to the Straits of Mackinac to perform the same geotechnical drilling as the jack up barge but in the deep water. Many of our ISMA member pilots from various lodges have been assigned to the *Highland Eagle* while she is operating in dynamic positioning mode to perform the drilling. PGP and Georgian Bay-Huronia Lodge #15 member **Sean O'Donoughue** was the first pilot onboard in the Straits and PGP **Lee Barnhill** transferred him from the *Highland Eagle* back to St. Ignace. Other ISMA member pilots who have also been assigned to the *Highland Eagle* are: **Chris Edyvean, Shawn McKenzie, Ian Macfie, Kevin Noseworthy**, and **Gary Adcock**.

Also working in the Straits on Line 5 is the Tug Kimberly Anne and barge Big Digger. They are diving on the pipelines performing inspections and coating repairs. The tug captain on the Kimberly Anne is ISMA member Scott Patterson.

ISMA members from Lodges across the Great Lakes are heavily involved in this highly sensitive project. It is good to see so many of our members on such a project operating with the professionalism expected of our great association.


# Industry Newsbriefs -

- On August 14, 2019, the US Coast Guard announced in the Federal Register that it is seeking public comment on a proposal to amend the requirements regulating personnel permitted to serve as a person in charge (PIC) of fuel oil transfers on an inspected vessel. Comments must be received by October 15, 2019. - On August 8, 2019, MV Indiana Harbor set a new cargo record for shipments through the Soo Locks. Her load of 76,930.5 NT of taconite pellets and deep draft of 30.4 feet broke the record set earlier this year on July 14, when MV American Integrity locked downbound with 76,358 NT of pellets at a deep draft of 30 feet.
- On August 1, 2019, Lake Carriers' Association released figures showing that the US economy lost more than \$1 billion in business revenue and 5421 jobs due to inadequate icebreaking capabilities on the Great Lakes during the 2018 -2019 winter season. Calculations indicated that US-flag lakers could have carried 4 million additional tons of iron ore and nearly 880,000 additional tons of coal if there were robust icebreaking capabilities. - Chamber of Marine Commerce President **Bruce Burrows** welcomed the Canadian federal government 's August 2, 2019, announcement that it is launching a competitive process to build six new icebreakers to operate in the St. Lawrence, Atlantic Canada, and the Arctic. In part, he said, "Canadian Coast Guard icebreaking services are essential to ensuring that the Great Lakes-St. Lawrence navigation system remains...reliable... We will continue to work with the government to ensure that adequate icebreaking assets are also available in the Great Lakes..." - On July 31, 2019, WI Senator **Tammy Baldwin**'s amendment calling for authorization of \$10 million for the "scope and design" of a heavy icebreaker for the Great Lakes to the 2020 Coast Guard reauthorization bill was approved by the Senate Commerce Committee with strong bipartisan support. It now heads back to the full Senate.
- Duluth's museum ship *William A. Irvin* was moved into drydock at Fraser Shipyards on August 1, 2019, for inspection, sandblasting and hull painting. Duluth Entertainment Convention Center, owner and operator of the *Irvin*, has received a \$500,000 grant from the Minnesota Historical Society to cover cost of the work

- On July 30, 2019, the US Maritime Administration announced designation of nine Marine Highway Projects, including one in the Great Lakes: Port of Oswego Great Lakes Container Service. The Port's goal is to expand its reach into national containerized cargo movement.
- On July 26, 2019, USCG's National Maritime Center announced that is is still seeking participants for the three remaining merchant mariner examination working group meetings in 2019: Deck working group September 10-12; Engine working group October 22-24; Deck working group December 3-5. - After a 2½-year layup, SS *Arthur M. Anderson* returned to service in late July 2019.
- > On July 23, 2019, the American Maritime Partnership released statistics showing that the US maritime industry creates more than 123,600 jobs and \$30 billion in economic growth in Great Lakes states. In fact, 20 percent of the national Jones Act impact comes from the eight Great Lakes states. - On July 22, 2019, the US Coast Guard issued a Safety Alert in response to the February fire aboard the laid-up MV St. Clair at Toledo. - Construction of Cleveland-Cliffs' hot briquetted iron (HBI) plant in Toledo is several months ahead of schedule. The plant is expected to open in 2020.
- The USCG has announced that the CG-2692 series of forms for reporting marine casualties has been re-approved by the Office of Management and Budget and updated with the new expiration date of July 31, 2022. Owners, agents, masters, operators, or persons in charge of a vessel should begin using the updated versions of the CG-2692 series immediately.
- In mid-July 2019, the US Navy announced that the *USS Indianapolis* littoral combat ship will be commissioned on October 26 at the Port of Indiana-Burns Harbor. This will be the first time a Navy vessel will be commissioned in the state of Indiana.
- ➤ On July 12, 2019, the USCG Office of Commercial Vessel Compliance published a policy letter to provide clarification and guidance regarding radar observer requirements. - On the evening of July 8, 2019, the crew of MV *Michipicoten* began a search operation in Lake Superior which led to the rescue of a jet skier at 0200 on July 9. The jet skier, out of Grand Portage, MN, was reported missing in a location very close to the *Michipicoten*'s eastward track across the lake. - On July 3, 2019, the crew aboard the mailboat J. W. Westcott II rescued a woman from the waters of the Detroit River.

- A July 1, 2019, *Journal of Commerce* article discussed project cargo – specifically wind turbines – on the Great Lakes/ Seaway thus far this season.
- Through June 30, 2019, cargo moved through the St. Lawrence Seaway was down 1.69 percent (213 tonnes) from the same period in 2018. Vessel transits numbered 1342 through June 30, 2019, down 50 from 1392 in 2018.
- On June 26, 2019, the Poe Lock reached a half-century of operation. Following dedication of the lock on June 26, 1969, SS *Philip R Clarke* was the first vessel to lock through the new Poe Lock.
