### FROM THE NELC

Port of Windsor imposes new fee for Ojibway Anchorage, ISMA fights back.

Late last year, during the pandemic, the board of the Port of Windsor met and passed a new fee schedule for the users of the port. On its own this is harmless; every port in the world reviews its fee structure annually to assess where capital improvements can be made and where revenue can be generated. In Windsor's case, the board decided to forego charging a "berthage fee" (a fee charged per foot of overall length of the vessel just for the privilege of tying up in the port) and implement a "harbor fee" (a fee charged per registered gross ton for a vessel entering the harbor). Prior to this new strategy, Windsor was the Canadian port on the Seaway that was not charging a harbor fee and now they are the only port not charging a berthage fee. The logical conclusion from the outside is that the board has maneuvered to capture more revenue from vessels merely anchoring at Ojibway to subsidize vessels actually using port facilities.

This is unacceptable for a multitude of reasons, but the highest priority is that it compromises the safety of the waterway. Vessels waiting for a berth now will slow bell up the river instead of being safely anchored out of the way, potentially putting them in conflict with vessels trying to enter the Rouge River. Foreign vessels going to Nicholson's will have to anchor at Belle Isle to await the berth and make two complete turns in the river, potentially causing more traffic delays.

I have sent a letter from the NELC to the port stating ISMA's arguments against this fee and outlining our concerns to the

safety of the waterway. In response, the CEO stated, "the era of free parking is over" and, "free market, free choice." What he fails to realize is that his port is not like any other Canadian port with an open body of water out front, but rather is situated on a confined waterway with only two available anchorages in approximately 80 miles of channel. In fact, Ojibway Anchorage was established, officially, around 1960 which coincides with the opening of the St. Lawrence Seaway in 1959 and the subsequent need for a designated anchorage in the Detroit/Windsor port complex. By contrast, Belle Isle anchorage did not officially show up on charts until 1982, and even then only as a "special anchorage."

### **Final Bells**

Georgian Bay-Huronia Lodge #15 member Lt. Ronald O'Donoughue, RCN (#12107) passed away on June 23, 2021,



in Owen Sound in his 80th year. Ron joined Lodge #15 in 2000 and served as lodge secretary-treasurer from 2003 to 2009. In 2005, he was instrumental in linking ISMA with the Canada Merchant Navy Veteran's Association and the placement of the World War II Merchant Navy memorial in Georgian College. Ron is survived by his wife of 57 years, **Donna**, three sons (including Lodge #15 president and Past Grand President Seann

O'Donoughue), and six grandchildren. A visitation and memorial service for Ron was held on August 7 at Brian E. Wood Funeral Home in Owen Sound.

A memorial service for Detroit Lodge #7 member Malcolm "Mac" McAdam took place on August 14, 2021. (Obituary appeared in the May-June 2021 ISMALetter.)

#### Members in the News

On June 13, 2021, Twin Ports Lodge #12 member Capt. William Carlson was awarded the prestigious Convoy Cup medallion and certificate for his service as a member of the Navy Armed Guard in World War II. The Convoy Cup Foundation, which bestowed the recognition, is a joint Nova Scotian and Norwegian organization which strives to "perpetuate memory of the courageous men and women who made possible the convoys consisting Merchant Navy and Air Force coverage." The event took place at the Honorary Consulate of Norway in Minneapolis. In attendance were members of ISMA Lodge #12,

family and close friends of Bill, and Consulate staff. Fox Channel 9 News Minneapolis documented the event.

Bill Carlson was aboard the MS City of New York when it was torpedoed off Cape Hatteras on March 29, 1942. The bravery and quick response of the Armed Guard crew, as they fired back at the attacking U-boat, bought time for passengers and crew to abandon ship. Bill kept firing his machine gun as the ship went under, and swam to a lifeboat that he helped command navigate for 16 days. In one of the crowded lifeboats, a pregnant passenger gave birth at night, in a storm. The ship's physician, US Merchant Mariner Dr. Len Conly, delivered the baby after breaking his own ribs trying to embark the lifeboat as the second torpedo slammed into the City of New York. The "Lifeboat Baby," Jesse Roper Mohorovicic, became known as the "baby Hitler couldn't get," and the amazing miracle of birth at sea in the face of imminent death was broadcast around the world to boost the morale of Allied troops.

- US NOAA is proposing to designate up to 1786 square miles of Lake Ontario and the Thousand Islands region adjacent to Jefferson, Wayne, Oswego, Cayuga, and St. Lawrence counties in New York as a National Marine Sanctuary. The nominated area contains 64 known shipwrecks and one aircraft representing events spanning more than 200 years of the nation's history. Based on historical records, an additional 20 shipwrecks and three aircraft may be located there. - The USS *Cod*, the World War II submarine, will return to its berth in Cleveland on August 18 or 19, 2021, following a two-month hull maintenance drydocking at DonJon Shipbuilding & Repair in Erie, PA.
- At noon on June 25, 2021, ships at ports across Canada sounded their horns as part of a worldwide effort to recognize the critical role marine workers have played during the pandemic and to urge governments to prioritize vaccinations for shipboard crews. June 25 was the International Day of the Seafarer.
- The US Coast Guard Marine Safety Information Bulletin (MSIB) 02-21 Change 2, issued on June 10, 2021, reflects updated enforcement of mask requirements for commercial vessels and maritime transportation hubs. - On June 25, 2021, Fraser Shipyards, Superior, WI, announced new owners. Cleaves Invest, out of Norway, and Chicago-based Foundry Mountain Infrastructure Partners acquired the yard in a joint venture known as Infrastructure Acquisition Partners. Patrick Kelly, of Foundry Mountain, is the incoming CEO of the 133-year-old shipyard.
- On June 10, 2021, Cleveland-Cliffs Inc. held a formal ribbon -cutting ceremony at its new natural gas-fired hot briquetted iron plant in Toledo., which has been operational for six months. At the ceremony, Cleveland-Cliffs' Chairman, President and CEO Lourenco Goncalves was joined by Rep. Marcy Kaptur (D-OH) from Toledo, Ohio Governor Mike DeWine, and Toledo Mayor Wade Kapszukiewicz.
- On June 23, 2021, it was announced that 962 square miles of Lake Michigan from Kewaunee County to Ozaukee County, WI, have been designated a National Marine Sanctuary to protect historic shipwrecks. This would become the 15<sup>th</sup> sanctuary established by NOAA. The designation is subject to congressional and gubernatorial review.
- Tug Edna G, long a fixture at Two Harbors, MN, will celebrate its 125<sup>th</sup> birthday with a two-day celebration on August 28 and 29, 2021.
- The pilot house of the Steamer Canopus, which had been on display at the former Great Lakes Historical Society Museum in Vermilion, OH, was auctioned by sealed bid on June 4, 2021. The former museum building was demolished in order to complete the city's Main Street Beach renovation. The *Canopus* pilot house was purchased through the auction by Bill and Eva Gribble, who plan to incorporate the pilot house as an entrance to their business which supplies recycled plastic materials to boat builders. The Canopus pilot house was moved over the road via truck on June 18.
